6. How do we share and disclose data?

6.2. Safety, Legal purposes, and Law enforcement. We will disclose your personal data (a) if we are required to do so by law, regulation or other government authority or otherwise in cooperation with an ongoing investigation of a governmental authority, (b) to enforce the Yodezeen's Site Terms of Use or user agreements or to protect our rights. 6.3. **Business transfers**. 6.5. **Service providers**. We may provide your personal data and the data generated by cookies and the aggregate data to the vendors and service agencies that we may engage to assist us in providing our services to you for their use solely to provide us with such assistance.

6.4. Aggregated data. Through the third party analytics providers and directly through our Site, we may track data that will be maintained, used and disclosed in aggregate form only and which will not contain your personal data. We may analyze this data for trends and statistics in the aggregate, and we may use such aggregate data to administer the Site and gather broad demographic data for aggregate use.

7. How do we handle your data?

In this section, we will tell you how we store, retain and secure data.

7.1. **Retention.** We retain your personal data on the protected server which is located within the European Economic Area.

We generally retain your personal data for as long as is necessary for the provision of our service to you and us and to comply with our legal obligations. If you request, we will delete or anonymize your personal data so that it no longer identifies you, unless, we are legally allowed or required to maintain certain personal data, including situations such as the following:

- Where we are required to retain the personal data for our legal, tax, audit, and accounting obligations, we will retain the necessary personal data for the period required by applicable law;
- Where necessary for our legitimate business interests such as fraud prevention or to maintain the security of our users.

7.2. **Security.** We operational and technological measures that are generally consistent with industry practice. Such measures are reasonably designed to help protect your personal data from loss, unauthorized access, disclosure, alteration or destruction. We may use encryption, secure socket layer and password protection to help prevent unauthorized access to your personal data.

Moreover, we are actively monitoring and enforcing the data protection standards during all of our activities, namely:

- Limitation of the rendered access to data only to those employees who need it for providing services to the user;
- Signature and external bv partners companies invited for the fulfillment of particular functions of non-disclosure agreements and agreements concerning non-usade of such data for anv unauthorized purposes;
- Signature of non-disclosure agreements by employees;
- Storing of the personal data obtained from the user in an encrypted form, at protected servers secured from unauthorized access.

8. Do we transfer your data?

9. What are your rights and choices?
